INVERSIONES AGUAS METROPOLITANAS S.A. ANNOUNCES CONSOLIDATED RESULTS FOR THE YEAR ENDED DECEMBER 31, 2010

(Santiago – Chile, January 31, 2011) Inversiones Aguas Metropolitanas S.A. "the Company" or "IAM", controlling shareholder of Aguas Andinas S.A. –the largest water and sewage company in Chile–, announced its consolidated results for the period ended December 31, 2010 ⁽¹⁾.

HIGHLIGHTS

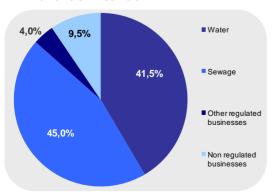
Net income of IAM as of December 31, 2010, amounted to Ch\$51,001 million as compared to Ch\$60,680 million for year 2009.

- Operating revenues amounted to Ch\$328,960 million, Ch\$846 million (0.3%) more than in the previous year. This was mainly due to higher sales volume and a combination of higher average tariff for sewage services, and lower average tariff for water services.
- Consolidated EBITDA for the year amounted to Ch\$203,277 million, lower by Ch\$1,202 million (-0.6%) as compared to the previous year. This variation was mainly explained by higher personnel costs and higher other expenses.
- Financial result reached Ch\$(29,341) million, lower by Ch\$20,843 million as compared to the previous year. This was mainly explained due to the positive variation in the value of the UF in the year 2010, which compares with a negative change in the value of the UF in 2009.
- Due to the above-mentioned factors, the consolidated Net Income of Inversiones Aguas Metropolitanas S.A. for the year ended December 2010 reached Ch\$51,001 million, compared to Ch\$60,680 million for the previous year.

PRINCIPALS EVENTS OF THE PERIOD

Aguas Andinas' Board approved new financing

On a meeting held on November 25, 2010, the Board of the subsidiary Aguas Andinas unanimously agreed to carry out the record and inscription of two bond issuance lines for a joint amount up to UF 4.4 million and maximum term of 30 years, which funds will be destined for the financing of investments and/or refinancing liabilities.

Interim Dividend Payment

On October 28, 2010, Inversiones Aguas Metropolitanas' Board of Directors agreed the payment of an interim dividend of \$16.3435 per share, totaling ThCh\$16,343,500 charged against the net income for the year 2010. This dividend was paid on November 24, 2010.

Resignation of Chief Executive Officer

At the Board Meeting of the Company, held on August 26, 2010, Mrs. Marta Colet, Chief Executive Officer of IAM presented her resignation to be effective on September 1, 2010. At the same meeting, the Board unanimously agreed to appoint Mr. Iván Yarur as CEO of the Company with effect since September 1, 2010.

New Controller Shareholder

On June 7, 2010, Suez Environnement Company S.A. acquired indirectly 75.1% of the share capital of Sociedad General de Aguas de Barcelona S.A. (Agbar), who, through different subsidiaries is the holder of 56.6% of the capital of IAM. Consequently, as from June 7, 2010, the new controller of IAM is Suez Environnement.

Supreme Court dictates definitive judgment in requirement of the National Economic Attorney's Office (FNE) in opposition to the sanitary companies Aguas Andinas, ESSAL, ESSBIO and Aguas Nuevo Sur Maule (ANSM).

The judgment, of May 18, 2010, confirms the absolution of Aguas Andinas and ESSAL, reduces the fines applied originally to ESSBIO and ANSM; and rejects the change in the law suggested by the Court of Defense of the Free Competition.

Final Dividend Payment

At the Annual Ordinary Shareholders' Meeting of the Company held on April 21, 2010, the payment of a final dividend of Ch\$44.679 per share (equivalent to Ch\$893.58 per ADS), totaling ThCh\$44,679,900, charged against the net income for the year 2009, was approved. The dividend was paid on May 19, 2010.

Appointment of a new Board of Directors

At the annual Ordinary Shareholders' Meeting of the Company held on April 21, 2010, the following Board members were elected:

Aguas Andinas' Bond Issuance

On April 14, 2010 the subsidiary Aguas Andinas issued UF2.75 million (US\$111 million) of Series K and M bonds in the Chilean market. The Series K (UF1.0 million) have a term of 6.5 years, with 1.5 years of grace and maturity the year 2016; the effective rate reached 2.90%, corresponding to a spread of 68 bps; the Series M (UF1.75 million) have a term of 21 years (bullet); the effective rate reached 4.08%, corresponding to a spread of 43 bps, the lowest spread for a private unguaranteed bond issuance in the history of Chile.

Consequences of the earthquake of February 27, 2010 in Chile

According to the requested by the Superintendency of Securities and Insurance (SVS), on March 3, 2010, the company and its subsidiaries informed the damages produced by the earthquake of February 27, 2010 in Chile. Inversiones Aguas Metropolitanas S.A. suffered no damage whatsoever, however, its subsidiary Aguas Andinas informed that its infrastructure was not significantly affected; hence the company kept almost normal operations, with water service coverage of nearly 100%, the only problems being shortages to electricity supply problems. The Company has insurance covering physical damage. Later, on May 25, 2010, Aguas Manquehue, subsidiary of Aguas Andinas, informed the SVS that after evaluating the damages, diverse breakdowns were identified in the north sewage collector, estimated in Ch\$2.224 million, informing likewise that has insurances to protect its infrastructure of eventual damages.

Aguas Andinas' tariff setting process agreement

The subsidiary Aguas Andinas and the Supenintendency of Sanitation Services (the sector's regulator), reached an agreement concerning the tariff setting process for the period 2010-2015. The accomplished agreement involves, in relation with the in force services, a Net Long-Term Total Cost as of October 31, 2009 of Ch\$229,494,000,000; which represents a variation, in currency of December, 2008, of -1.3%. The same agreement contemplated stipulation of tariffs for the concepts of Mapocho Urban Cleaning project, necessary works to reach 100% of sewage treatment and safety works for the production of drinkable water in the Santiago. The tariffs were set by means of decree No. 60 of the Ministry of Economy, dated February 2, 2010; and are in force since March 1, 2010.

Operating Revenues

Operating revenues as of December 2010 reached Ch\$328,960 million, Ch\$846 million more (0.3%) than in the previous year. The following table sets forth, for the periods indicated, the principal components of our net revenues:

The increase in net revenues as of December 2010 resulted mainly from the following factors:

- a) Water: Water revenues show a decrease of Ch\$9,044 million, which is explained by a lower average tariff, offset by larger sales volume of 10 million m³. The change in the average tariff is due to the accumulated effect of indexation adjustments during 2009 and 2010, a new tariff in force since March 2010, and a positive tariff indexation in June 2010.
- b) Sewage: Sewage revenues show an increase of Ch\$8,871 million explained by:
 - i. Higher collection revenues of Ch\$3,023 million (Ch\$74,534 million in 2010 compared to Ch\$71,511 million the previous year), due to increased sales volume of 11.3 million m³, and a higher average tariff;
 - ii. Higher treatment revenues of Ch\$4,566 million (Ch\$58,486 million in 2010 compared to Ch\$53,920 million the year before) due to increased sales volume of 10.3 million m³ and a higher average tariff applied, which is related to the star up of the Mapocho Urban Cleaning project; and
 - iii. Higher revenues from sewage inter-connections of Ch\$1,283 million (Ch\$15,149 million in 2010 compared to Ch\$13,867 million the previous year), due to higher average tariff, which is related to the star up of the Mapocho Urban Cleaning project, and higher sales volume of 2 million m³.

The change in the average tariff is due to the accumulated effect of indexation adjustments during 2009 and 2010, and a new tariff in force since March 2010. The decrease is partly offset by the tariff of the Mapocho Urban Cleaning project, in force since April 1, 2010.

- c) Other regulated businesses: includes fixed charges, revenues relating to disconnection and reconnection charges, fees relating to monitoring activities of liquid industrial waste discharge and accruals for non-billed consumption and discounts granted on payment agreements. These revenues increased by Ch\$1,836 million due mainly to higher income accruals of Ch\$2,849 million, partly offset by lower revenues relating to other distribution revenues of Ch\$449 million, lower fixed charges of Ch\$182 million and lower disconnection and reconnection revenues of Ch\$306 million.
- d) Non-regulated businesses: Revenues from non-regulated businesses show a decrease of Ch\$818 million, mainly due to a decrease of Ch\$502 million relating to lower revenues in nonregulated water businesses (real-estate development agreements and engineering services, among others); and lower revenues in Gestión & Servicios of Ch\$2,657 million; partly offset by higher revenues in Ecoriles of Ch\$2,092 million (liquid waste treatment plant operation and treatment of excess organic load for industrial companies) and larger revenues in ANAM of Ch\$249 million (laboratory, sampling and analysis services).

Consumption of Raw Materials and Secondary Materials

These costs amounted to Ch\$23,024 million as of December 2010, a decrease of Ch\$4,813 million over the previous year, mainly explained by lower energy costs of Ch\$2,913 million and lower various materials costs of Ch\$2,025 million.

Personnel Expenses

These amounted to Ch\$38,313 million as of December 2010, Ch\$2,577 million more than in the previous year, mainly explained by term bonds related to collective bargaining.

Depreciation and Amortization

These amounted to Ch\$53,034 million as of December 2010, Ch\$2,434 million higher than in the previous year, mainly explained by the new investments of the company.

Impairment Loss

This amounted to Ch\$1,560 million as of December 2010, due to assets damaged by the earthquake of February 27, 2010. The main losses were in Aguas Manquehue of Ch\$1,120 million (North Zone Sewage Collector) and Aguas Andinas of Ch\$429 million.

Other Expenses

These amounted to Ch\$64,344 million as of December 2010, Ch\$4,284 million more than as of December 2009, mainly explained by higher expenses from treatment plants management of Ch\$5,406 million, partly offset by lower consulting expenses of Ch\$1,401 million.

Financial Income

This amounted to Ch\$4,291 million as of December 2010, Ch\$849 million less than in previous year, mainly explained by reduced income from clients debt interests of Ch\$811 and lower financial assets.

Financial Expenses

These amounted to Ch\$22,744 million as of December 2010, Ch\$336 million higher than in the year 2009, mainly explained by higher financial debt due to bonds issued in April, 2010.

Results of Indexation Adjustments

This charge amounted to Ch\$(10,866) million as of December 2010, Ch\$19,596 million less than in the year 2009, mainly explained by a higher debt revaluation due mainly to the positive variation in the value of the UF in 2010, which compares with a negative change in the value of the UF in 2009.

Other Income

Inversiones Aguas Metropolitanas S.A obtained a result of Ch\$3,802 million, Ch\$25 more than as of December 2009, explained by advance payments from insurance companies of the damages related to the earthquake of February 27, 2010; partly offset by lower income on land sales.

Charge (Recovery) for Income Taxes

The provision for income tax as of December 2010 was Ch\$6,351 million lower than in the year 2009, mainly related to lower pre-tax income.

Net Income (Loss)

For the reasons set out above, the net income of Inversiones Aguas Metropolitanas as of December 2010, amounted to Ch\$51,001 million; Ch\$9,679 million less than in 2009.

EBITDA

Consolidated EBITDA for the period amounted to Ch\$203,277 million, lower by Ch\$1,202 million (0.6%) as compared to the year 2009.

Assets

As of December 2010, current assets decreased by Ch\$15,773 million over December 2009, mainly due to lower cash and cash equivalents of Ch\$18,837 million, due to higher investments payment, partly offset by a raise in current tax assets of Ch\$2,681 million.

Long-term assets rose by Ch\$22,734 million compared to December 2009, mainly explained by the net increase in Property, plant and equipment of Ch\$13,547 million, due to higher investments and

the acquisition of Sociedad Eléctrica Puntilla S.A. (EPSA) shares of Ch\$7,221 million in November 2010.

Liabilities and Shareholders' Equity

As of December 2010, current liabilities decreased by Ch\$22,689 million over December 2009, mainly explained by lower current financial liabilities of Ch\$14,268 million (due to bank debt preamortizations), lower sundry creditors and other accounts payable Ch\$19,115 million and lower income taxes of Ch\$4,280 million. This was partly offset by higher accounts payable to related companies of Ch\$16,024 million.

Long-term liabilities increased by Ch\$46,061 million compared to December 2009, due to an increase in other long term financial liabilities of Ch\$40,883 million explained by bonds issued by the subsidiary Aguas Andinas in April 2010, and higher deferred income of Ch\$7,221 million due to the acquisition of Sociedad Eléctrica Puntilla S.A. (EPSA) shares in November 2010.

The controller's portion of Shareholders' equity decreased Ch\$7,818 million and Net Shareholders' equity, including Minority Interest, decreased by Ch\$16,410 million.

The cash flow from operating activities showed a negative change of Ch\$10,030 million compared to the previous year, mainly explained by a decrease in collection of trade account receivables of Ch\$6,504 million, higher other operating payments of Ch\$4,561 million and higher income tax paid of Ch\$4,205 million. This was partly offset by lower interests of Ch\$5,410 million.

Cash flow from investment activities decreased by Ch\$13,551 million, mainly due to lower addition of property, plant and equipment of Ch\$17,774 million, partly offset by a decrease in proceeds from sales of PP&E of Ch\$3,788 million.

The cash flow from financing activities increased by Ch\$46,892 million, the main changes being higher dividend payments of Ch\$16,241 million and higher loan payments of Ch\$17,284 million.

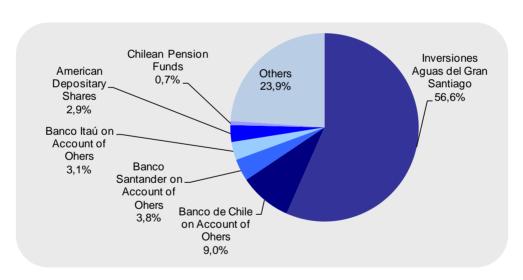
